Dear Clagett Sailing Regatta Participants, Coaches and Volunteers,

Clagett Sailing's Board of Directors would like to stress that the following COVID-19 safety requirements are intended to keep all participants and volunteers safe. Please understand that the challenges and safety guidelines associated with COVID 19 continue to change.

Clagett Sailing's Medical Committee met on April 26, 2022 to discuss the current public health situation, specifically the impact of COVID-19 on the safety of participants at all Clagett Sailing events, including Clagett Sailing's C. Thomas Clagett, Jr. Memorial Clinic and Regatta (Clagett Newport) in June of 2022 and Clagett/Oakcliff in September of 2022. Our primary concern is for everyone's health and safety.

After receiving the most recent medical information in the State of Rhode Island, Clagett Sailing's Medical Committee has decided that, for the protection and safety of everyone involved at Clagett Sailing events, **proof of Up to Date COVID-19 vaccination status will be required at Clagett Newport from June 21-26, 2022 and at Clagett/Oakcliff from September 9-11, 2022.**

Up to Date vaccination status means that person has received their primary series of vaccines against COVID-19 and at least one booster shot.

Entry to Clagett Sailing events, including Clagett Newport and Clagett/Oakcliff, will only be permitted for those who are Up to Date on their COVID-19 vaccines. Everyone must stay flexible as the CDC guidelines may change again as we approach the Regatta in June.

Proof of Up to Date vaccination is required for **anyone in Clagett Sailing's space at Clagett Sailing events, including Clagett Newport or Clagett/Oakcliff**—participants, volunteers, coaches, aides, family and friends of sailors or volunteers—who must present proof of vaccination in the form of a physical vaccine card or official verification record from an official source (eg...RI department of health) which can be electronic. On completion of check-in those with a verified Up to Date status will be given an identification tag to be worn at all times. Only those with this identification will be allowed in the Clagett Sailing space on land as well as on the water.

For everyone's safety, do not travel to Clagett events including, but not limited to, Clagett Newport or Clagett/Oakcliff, without verification of your Up to Date vaccine status (primary series of vaccines against COVID-19 and at least one booster). If you have questions please call the office at 401-846-4470.

For those competitors who choose not to participate, or are unable to participate, a registration refund will be issued.

All participants, volunteers, coaches, and individuals expecting to interact with Clagett Sailing in any way, are expected to follow these guidelines while at Clagett Sailing events, including Clagett Newport, Fort Adams State Park from June 21-26, 2022 and Clagett/Oakcliff in Oyster Bay, NY from September 9-11, 2022.
